## OTHER RELEVANT INFORMATION

You Can Help: CWA and LGRA race meets require a lot of effort from a lot of people. When you come to race - if you can - please bring a person along to help slip and catch your dog(s) since you can't do both at once. Bring your spouse, your significant other, your granny, the neighbor kid, whomever. Who ever it is, if he/she has two legs and can count to four, we can put them to work!

In addition, when your breed is not running, please plan to help with other people's dogs or by acting as a foul judge or finish line judge.

Also, GIT and AAWC invite your assistance setting up and tearing down the track. Even if you are unable to lift heavy equipment or carry material notable distances, your help with general "clean up" is always needed and appreciated. Please do not leave the meet without helping.

Box Training \& Practice: If your registered hound has not seen the boxes for a while, plan to join box-practice early on Saturday or Sunday (8:00a). If you have unregistered hounds that you'd like to practice, plan to "work in" between programs or after the meet.

## Directions to Site:

From the north, take I-44 West into Oklahoma. Pick up US-69 South in Oklahoma to US-75 South in Texas (names change, but roads do not). From US75 South, exit Hwy 380 (exit \#42). Then see "From all directions"
From the south, take I-35E North from Hillsboro to US-75 North. Exit Hwy 380 (exit \# 42) and turn left toward Denton. Then see "From all directions"
From all directions, McKinney is located approximately 33 miles northeast of downtown Dallas via U.S. Highway 75 (North Central Expressway). From US-75, take Hwy 380 exit (exit \#42) and head WEST approximately 2.5 miles until you reach FM 1461. Turn right (NORTH) on FM 1461 and travel approximately 3.8 miles to County Road 166. Turn right (NORTH) on CR 166. Go about a mile. You will see Myers Park on your left. Do not turn in. Continue until you reach the stop sign at County Rd 168. Turn left (west) onto County Road 168

On the left you will see the MPEC offices and a large yellow metal barn. Continue past that area to the next gate on your left. This will be just before a small white house. Turn left into that gate. See the drawing below.

Amenities on Site: Myer's Event Center has water spigots available, and the water is suitable for your hounds to drink and/or to cool down. Little shade is available, however, and a pop-up tent is recommended. Permanent bathroom facilities are available at a distance from the field and portable restrooms are in close proximity to our track set-up. GIT will have lunch and beverages on hand for purchase.

Lunch: A lunch for purchase will be offered by GIT or fast-food options are nearby (within 6 miles)

Sleeping on the Back Forty: is allowed for a fee of $\$ 10$ per tent for the weekend (Saturday/Sunday). Electricity is available on the field at the rate of $\$ 40$ per calendar day. If you wish to bring an RV, please notify Mark Page at Myers Park in advance so appropriate arrangements with the Park can be confirmed. His contact info is as follows: (972) 548-4792

Be sure to protect yourself and dogs from fleas and ticks. The track is shaded until about 11am. Bring your own shade, water, chairs. Water is available about $1 / 2$ miles away.

All dogs are required to wear muzzles and racing jackets

All persons must clean up after their hounds. A penalty of $\$ 5$ will be assessed for any loose hounds not competing in the race in progress.

## Workers:

All available to help foul judge and line judge should do so. It takes many bodies to make a race run successfully and we will need help boxing dogs, catching dogs and at the line. So please be prepared to work.

## Directions: Please use the directions and not a gps device.

From I-44 southbound (exit \# 289) - take the Vinita exit, follow hwy 60 into town of Vinita, at $2^{\text {nd }}$ stoplight turn right (north). Go to $1^{\text {st }}$ stoplight and turn left (west) (this is Hope rd \& county road 250), follow this road approx. 3-4 miles until road curves right (north) Do NOT take the curve Go Straight approx 1 mile, track is on north side of road. Approx 1 mile of gravel road this direction.

From I-44 northbound (exit \# 283)- take the Big Cabin exit, go north on hwy 69 to hwy 60, then go left (west) on hwy 60 toward Nowata, go to county road 4340 marker signs there that say Tempson Chapel and Robson Ranch.
